Contributions are not tax deductible. Anonymous contributions are prohibited. Cash contributions are limited to \$50. By filling out this form, you are certifying that you are a U.S. Citizen eligible to make a political contribution under Denver law. Denver Municipal Code requires that we make the best efforts to obtain the occupation and employer of any personal contribution \$200 or more per election cycle. Federal officeholders appearing on this invitation are prohibited from soliciting donations larger than that allowed by federal law, which is up to \$2,500 per election. Additionally, they are prohibited from asking for funds from corporations, labor organizations or other federally prohibited sources.
